*A minimum of 20% of the work on which the final grade is based will be evaluated and available to the student before the voluntary withdrawal date.

Course Objectives / Learning Outcomes

The primary objective is to provide the student with additional OO software design techniques suitable for professional practice and for the Applied Computer Science Project Course. In particular the course covers several software design patterns using UML and Java. For each of the patterns the student learns when and how to apply the pattern, and understands its structural and behavioural aspects. The student's knowledge of Java and programming

capabilities are advanced. The student's knowledge of UML class, object, statechart, and sequence diagrams is advanced. The student is prepared to further their study of design patterns in software design, human computer interaction, database, etc.

Evaluation Criteria

1. Assignments (25%)
 - 4 assignments, worth 5-8% each
 - Individual due dates and weighting will be posted on Nexus
 - Assignments will be accepted up to 1 day late with a 20% penalty

Lab/assignment submissions:

All work is to be submitted electronically. All coding is to be submitted in .java format, and any written work or diagramming in PDF format. Further details and submission procedure will be stated in each assignment.

Students are responsible for backing up and protecting their assignment work.

2. Midterm Test (25%)
 - During the regular class time (see Important Dates)
3. Final Exam (50%)
 - Cumulative

Students should contact the instructor as soon as possible if extenuating circumstances require missing a lab, assignment, test or examination. A medical certificate from a practicing physician may be required before any adjustments are considered.
